**SUB: APPROVAL OF AFFILIATION OF PADMASHREE DR.  
D.Y. PATIL COLLEGE OF LAW, MUMBAI.**

Sir,

The Report of Inspection of the above Law College submitted by the Inspection team of the Bar Council of India was placed before the Legal Education Committee at its meeting held on 28<sup>th</sup> & 29<sup>th</sup> June, 2002 and Legal Education Committee made the following recommendations:-

"The Legal Education Committee considered the inspection report of Padmashree Dr. D.Y. Patil College of Law, Mumbai submitted by the inspection team of the Bar Council of India. After consideration Committee is of the view that temporary approval of affiliation may be granted to the above College for a period of one year i.e. for the academic year 2002-2003 for imparting five year day law courses with intake of two sections of 80 students in each subject to the following conditions:

1. That the college will construct its independent building within two years.
2. That the College will not admit the students till the ordered books are received in the college library.

Management is required to submit the compliance of the above mentioned conditions within a period of four months."


The above recommendations were considered by the Bar Council of India at its meeting held on 30<sup>th</sup> June, 2002 and accepted the same.

The College shall also comply with the following Rule 23 in Section A in Part IV of the Bar Council of India Rules:

"Whenever approval of affiliation is granted to the law college it shall be necessary for the college to deposit in cash Rs. 1,00,000/- (one lakh) in the shape of guarantee to fulfil all the norms of the Bar Council of India. The same shall be liable to be forfeited if the norms are not complied with and the same shall carry no interest."

The approval of affiliation now granted by the Bar Council of India is subject to the payment of guarantee amount as mentioned in the above rule.

The Report of Inspection of the above Law College submitted by the Inspection team of the Bar Council of India was placed before the Legal Education Committee at its meeting held on 4<sup>th</sup> & 5<sup>th</sup> April, 2003 and Legal Education Committee made the following recommendations:-

"The Legal Education Committee considered the inspection report of Padmashree D.Y. Patil College of Law, Navi Mumbai submitted by the inspection team of the Bar Council of India. After consideration Committee is of the view that the above law college may be granted extension of approval of affiliation to impart three year as well as five year law course for a period of three years i.e. from the academic year 2003-2004 to 2005-2006 with intake of two sections of 80 students in each course subject to fulfilment of below mentioned conditions;


1. That the College will pay Rs.150/- per lecture to the visiting lecturers.
2. That the college will spend Rs.50,000/- on library every year.
3. That the College will construct the exclusive building for the law college within a period of two years.

College authorities will furnish written undertaking within one month from the date of receipt of the communication that they will comply with the aforesaid conditions, failing which approval of affiliation will not be extended further."



The above recommendations were considered by the Bar Council of India at its meeting held on 5<sup>th</sup> & 6<sup>th</sup> April, 2003 and accepted the same.

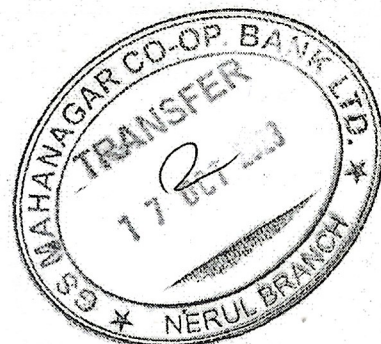
